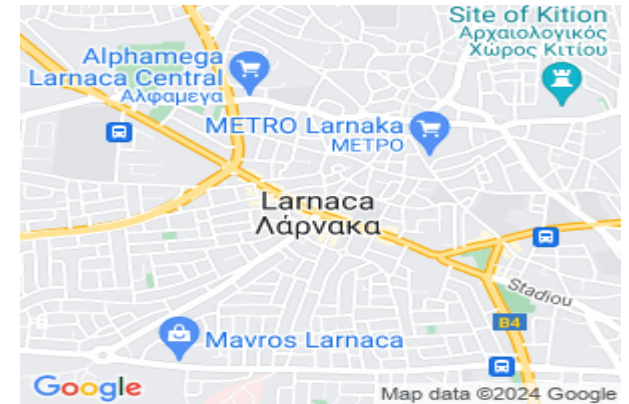

The building consists of: - Ground Floor shop with enclosed area 210 sq.m. with mezzanine 110sq.m. - Apartment 101 on the first floor with enclosed areas 122 sq.m. and 24 sq.m. covered balconies. - Apartment 102 on the first floor with enclosed areas 80 sq.m. and 12 sq.m. covered balconies. - Apartment 201 on the second floor with enclosed areas 110 sq.m. and 22 sq.m. covered balconies. - Apartment 202 on the second floor with enclosed areas 80 sq.m. and 12 sq.m. covered balconies. The property is located in a very central location of Larnaca just 85m from the motorway on a walking distance of many amenities such as schools, supermarkets and services.
