The property has a rectangular shape with a flat surface and is located in New Port area within Zakaki parish of Limassol. The access to the field is via two registered roads with a total frontage of approx. 250m. This land offers a strategic location close to all major amenities, making it ideal for commercial or industrial development warehouse/ office spaces/ logistics etc. The property abuts the road on the port roundabout and is near key attractions and business hubs, with easy access to transportation and major roads. It is located within a short distance from MyMall Limassol and the City of Dreams Mediterranean approx. 2km. This ensures the high potential for significant returns on investment. The property falls within three Zones: - Zone Eβ6(65%), with a building coefficient of 100%, coverage of 50%, and permission for 3 floors 13.5m of construction - Zone Bβ2(5%), with a building coefficient of 90%, coverage of 60%, and permission for 2 floors - Zone Bα4-BE2(30%), with a building coefficient of 90%, coverage of 60%, and permission for 2 floors.

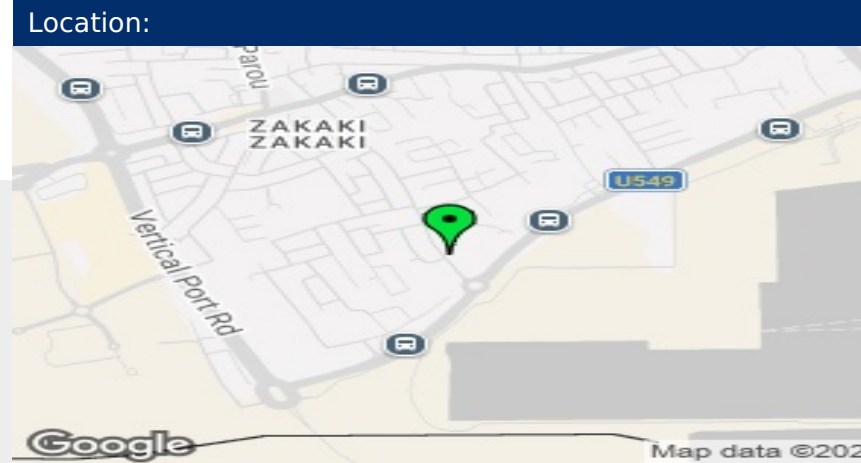
