This property is a commercial building that was previously used as a restaurant, located in Nempetchane within the walls of Nicosia. The building consists of several levels. The basement, approximately 84 sqm, includes a wine cellar, walk-in refrigerator, storage space, and a staff toilet. The ground floor, around 82 sqm, features a kitchen and three dining areas. The first floor, measuring about 86 sqm, offers another dining area along with guest toilets. Additionally, there is a terrace of approximately 48 sqm. All levels are interconnected by an elevator and a staircase. The property is located in the old city walls of Nicosia, an area characterized by listed buildings with both residential and commercial uses, serving as the traditional commercial center of the city.

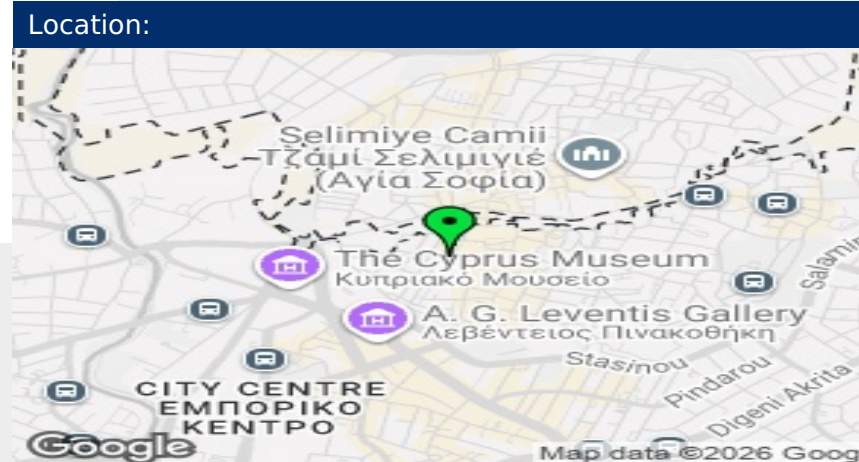
