Architectural details such as marble flooring, refined finishes, and two fireplaces enhance the sense of warmth and sophistication, while large openings connect seamlessly to the outdoor spaces. The west-facing main veranda, complete with pergolas, offers the perfect setting for relaxed evenings, while the east-facing patio captures gentle morning light. The property features four spacious bedrooms, including a master suite with a walk-in closet and ensuite bathroom, along with an additional office space or maid’s room. In total, there are four bathrooms and five WCs, ensuring convenience for both residents and guests. A modern Italian designer kitchen with built-in appliances combines functionality with sleek aesthetics, complemented by a dedicated laundry room and two ground-floor storage areas. Additional features include central heating, air conditioning, ceiling fans in the bedrooms, and double-glazed windows for year-round comfort. The home is offered unfurnished, with all electrical appliances installed, allowing for immediate personalization. Parking is well accommodated with two covered spaces and one uncovered spot. The surrounding tree-lined streets add to the tranquil atmosphere, while the prime location places the property within walking distance of embassies, the city center, and key cultural landmarks of Nicosia. 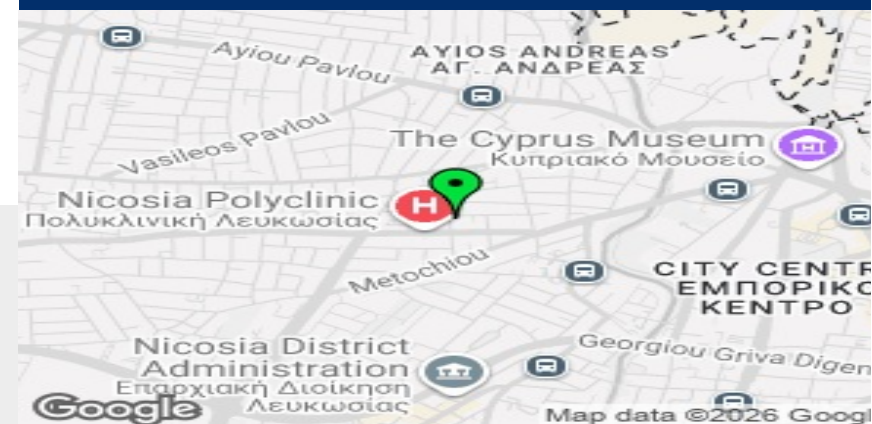
