The property is a mixed-use building located in Agioi Omologites, Nicosia, occupying a prominent corner position at the junction of John Kennedy Avenue and Andrea Araouzou Street. It lies just 450 meters from Nikis Avenue and the Ministry of Energy, Commerce and Industry. The building comprises a basement with parking and storage areas, three ground-floor retail units with mezzanines, and residential or office units on the upper floors. Two of the retail spaces are currently vacant, while the corner unit operates as a kiosk. It offers a total covered area of 1,500sqm, a basement of 325sqm, mezzanine spaces totaling 170sqm, and 98sqm of covered verandas, all situated on a 578sqm plot. Ideally positioned close to Nicosia’s city center, the property benefits from excellent access to amenities and services. Sale will be completed through a Sale and Purchase Agreement.

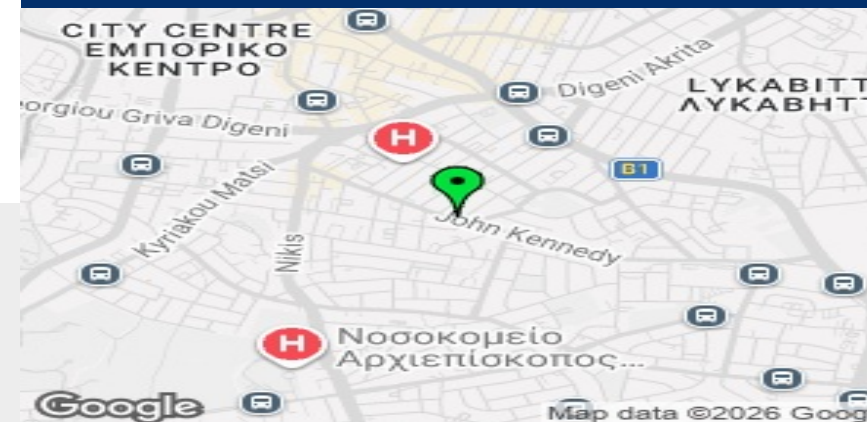
