The building is situated on a 671sqm plot and offers a total covered area of approximately 369sqm, comprising a 276sqm ground floor and a 93sqm mezzanine. It benefits from approximately 26m of road frontage. The ground floor comprises a reception area, a large open-plan space, two toilets, a shower, a kitchen, an additional room, and a small storage area. The mezzanine consists of two rooms and a toilet. The property enjoys a strategic location within Lympia village centre, approximately 15m east of Archbishop Makarios III Avenue, 85m east of Saint George Church, 405m south of Lympia Primary School, and 785m north of the Larnaca-Nicosia motorway. The property has a separate title deed. It is noted that the property cannot be purchased with a mortgage.

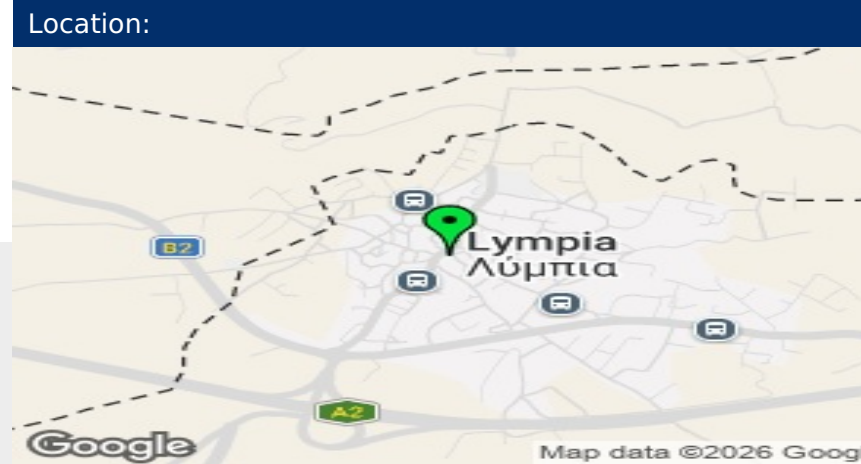
